DISSEMINATION OF EFFECTIVE TREATMENT MODALITIES

Study Mandate

The Virginia Commission on Youth (VCOY) is to:
Make empirically based information concerning effective treatment modalities and practices for children (the “*Collection*”) available through web technologies;
Seek the assistance of the Collection Update Advisory Group, Secretary of Health and Human Resources, Secretary of Public Safety, and Secretary of Education in posting, maintaining and biennially updating the *Collection*; and
Develop a cost-effective and efficient dissemination method to allow for easy access to the information.

Issues

- The *Collection* was originally published in 2002, and is updated biennially. VCOY previously adopted a work plan to update the *Collection 5th Edition* to reflect the revised American Psychiatric Association’s *revised Diagnostic & Statistical Manual of Mental Disorders Fifth Edition (DSM-5)*. The *DSM-5* is the 2013 update to the American Psychiatric Association’s classification and diagnostic tool. In the U.S., the DSM serves as a primary authority for psychiatric diagnoses, treatment recommendations, and reimbursement by health insurers.
- The *Collection* has been widely used since its first publication in 2002 and is tailored for parents, caregivers, educators, service providers, and others with an interest in children’s mental health. Monthly web hits for the *Collection* can reach up to 40,000.
- Commission staff is finalizing the update of the *Collection 6th Edition* to reflect the revised *DSM-5* as well as updated research about evidence-based practices for children and adolescents with mental health treatment needs. The *Collection 6th Edition* has been updated with the assistance of an advisory group of experts.

- The *Collection 6th Edition* is a resource for providers, families, and other entities or individuals working with children with mental health treatment needs by providing them with current information on evidence-based treatment modalities.
- The intent of dissemination is to spread knowledge and awareness about evidence-based practices. The field of child and adolescent mental health is multi-disciplinary, with a diverse service system. There are a multitude of treatment guides and resources, which makes it very difficult for service providers and families to make informed choices. Evidence-based practices serve as a guide by allowing families, clinicians, and other mental health decision-makers access to information on what treatments have been proven to be effective.
