I. Call to Order and Opening Remarks

Senator Barbara A. Favola, Chair

Senator Barbara Favola called the meeting to order and welcomed Commission members and attendees. Senator Favola introduced Amy Atkinson, Executive Director for the Virginia Commission on Youth, to review the proposed study plans and initiatives for the 2025 study year.

II. Approval of Commission on Youth 2025 Study Plans and Initiatives

Amy Atkinson explained the five 2025 studies and initiatives requested consideration and approval from Commission members to complete the studies during the current year. The studies included the following:

- Discharge Planning from Inpatient Treatment to a Public School
- Review of Virginia's Special Education Dispute Resolution System

- Collection of Evidence-Based Practices for Children and Adolescents with Mental Health Treatment Needs
- Office of the Children's Ombudsman Relief of Custody Work Group
- School-Based Mental Health Review

III. Review and Approval of Commission on Youth Remote Meeting Policy

Will Egen reminded the Commission that based on current law the Commission must at least once annually adopt a policy on remote meeting participation, if the Commission wishes to allow its members to use remote participation. Mr. Egen described the current policy before the Commission which is identical to the policy adopted by the Commission on October 22, 2024. After presenting, a motion was made and seconded and the policy was adopted unanimously.
